Administrative and Biographical History:	The Bar Convent was purchased in 1686 following a donation from Sir Thomas Gascoigne (1596–1686) who requested that "we must have a school for our daughters". As well as the convent, one of the earliest girls' schools in the country was established by Sr Frances Bedingfield (1616–1704) at a house on what is now 17–19 Blossom Street, just outside the city walls of York and Mickelgate Bar, and has been in operation since that date. Founded by Mary Ward (1585–1645), the members of her order (later known as the Institute of the Blessed Virgin Mary, and since 2003 as the Congregation of Jesus) operated both a fee-paying boarding school and a Day School on the site. In the 1920s the two schools were merged into a grammar school which continued to be run by the sisters until 1985. At that time, it was handed over to lay management and merged with two other local grammar schools to become All Saints Comprehensive. It continues under this name today.
	In the 1760s, an increased number of fee-paying pupils on the books ushered in a period of financial security, precipitating a period of physical building and improvements. The celebrated Georgian architect Thomas Atkinson (1729–98) designed and built the house frontage, a hidden chapel and other rooms between 1766 and 1789, alongside other commissions such as the palace of the Archbishop of York in nearby Bishopthorpe. The Georgian frontage enclosed what had previously been a utilitarian courtyard between numbers 17 and 19 Blossom St, providing a grand entrance to the flourishing schools, and still functions as the main entrance of the convent today.
	Additional adjoining houses, including numbers 21, 23 and 25 Blossom Street were purchased from the 1780s onwards, and in the 1840s they were clad with a uniform façade in harmony with the rest of the building. This was designed by the 'railway architect' George Townsend Andrews (1804–55), who also glazed and tiled the entrance courtyard with a cast iron and glass roof and coloured Maw tiles, one of the last Maw floors surviving in the world. In 1835, additional rooms were also added to the convent, including a refectory and two kitchens for the boarders. These are still in use as the Bedingfield, Gascoigne and Aspinal function rooms respectively.

In 1985 at the time of the school changes, the purpose and use of the Bar Convent itself was also changed entirely. Still a living convent, the sisters created a heritage property which encompassed a museum, café, shop and youth centre. Financial and administrative difficulties forced closure in 1994, and following refurbishment work and the appointment of Richard Masefield as first General Manager in 1995, meeting rooms were added and the youth centre converted into a Bed and Breakfast under the management of Leslie Baines until her untimely death in 2022. The St Bede's Pastoral Centre was also established in 1987 at the adjoining property of 21 Blossom Street. The centre was staffed by Benedictine monks from Ampleforth until 1993, since which time it has been managed by the sisters, and since 2017 under a lay Director [see ACJ: SB – St Bede's Collection].

From 2010 a successful fundraising campaign raised funds to design and install a brand-new museum, now the Living Heritage Centre, which was officially opened by Alex Polizzi and Sr Jane Livesey in October 2015. Function rooms and guest bedrooms were revamped, and the convent continues to function as a well-used and much beloved aspect of York's rich history.
